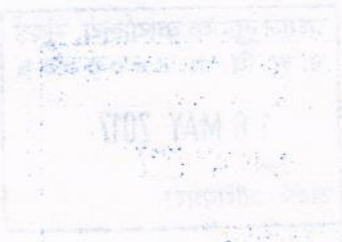

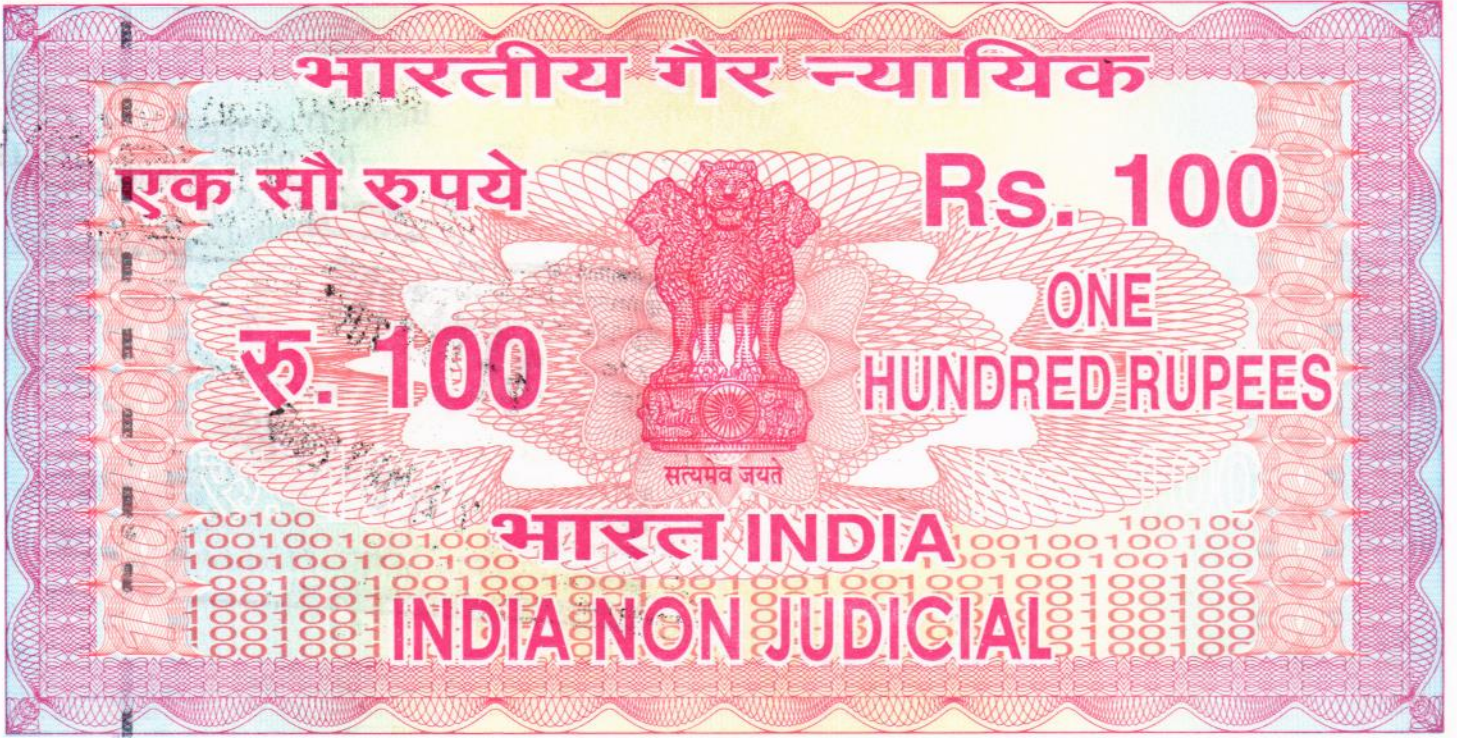

- (a) the Assignor is able to continue to effectively license Indian Literary Works and Indian Musical Works in International Territories and with International Services (including those having Indian subscribers)
- (b) the receipts due and payable to Author and/ or Composer members of the Assignee from the Assignor's licenses granted for International Territories and International Services to the extent attributable to rights granted to Assignee pursuant to the Deed (as varied herein) are received by the Assignee (for distribution to Author and/ or Composer members of the Assignee) in a timely, credible and efficient manner and
- (c) the scope of the Deed accurately reflects the extent of the rights in Indian Literary and Musical Works held by the Assignor which are granted to Assignee.

AND WHEREAS the Parties have now by mutual agreement resolved to amend certain provisions of the Assignment Deed, by including clarifications and new provisions, as more particularly set out below.
